Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001:

Application of Uzoma Ogbuokiri, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under Subtitle D § 5201 from the lot occupancy requirements of Subtitle D § 304.1, to construct a 3-story rear addition to an existing semi-detached principal dwelling unit in the R-2 Zone at premises 7521 9th Street, N.W. (Square 2961, Lot 18).

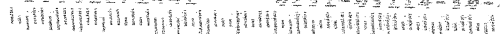
