The Board of Zoning Adjustment (Board or BZA) will consider the following application during the public hearing session scheduled for <u>Wednesday, March 11, 2020 beginning at 9:30 a.m.</u>, in the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4<sup>th</sup> Street, N.W., Suite 220 South, Washington, D.C., 20001:

**Application of Paul and Marilyn Pearlstein,** pursuant to 11 DCMR Subtitle X, Chapter 9, for special exceptions under Subtitle D § 5201 from the minimum side yard requirements of Subtitle D § 507.1, and the accessory building side yard requirements of Subtitle D § 5005.1, to construct a rear addition on the existing, detached, principal dwelling unit in the R-8 Zone at premises 2928 Ellicott Street, N.W. (Square 2270, Lot 8).

  - Upload your document to the case record in IZIS or, if you have technical difficulties with IZIS, send it as a PDF attachment by email to <a href="mailto:bzasubmissions@dc.gov">bzasubmissions@dc.gov</a>
  - Electronic submissions sent after 9:00 A.M. on the morning of the hearing will not be accepted into the record. Hard copy documents may be submitted to the case record by delivering in person at the time of the hearing when the case has been called by the Secretary.
- **B.** Attend the hearing and provide oral testimony as a "person in support" or "person in opposition" at the hearing.
- **C. Apply for Party Status** for more in depth involvement in the case.
  - Upload a Party Status application (Form 140) to the case record in IZIS or send to <a href="mailto:bzasubmissions@dc.gov">bzasubmissions@dc.gov</a>
  - Applications for Party Status **must be filed with the Board 14 DAYS PRIOR** to the <u>originally</u> scheduled hearing date set forth in this letter.
