Application of Brittney Etheridge, pursuant to 11 DCMR Subtitle X, Chapter 9, for special exceptions under Subtitle F § 5201 from the lot occupancy requirements of Subtitle F § 304.1, and from the rear yard requirements of Subtitle F § 305.1, to construct a second-story rear addition to an existing, attached principal dwelling unit in the RA-1 Zone at premises 407 51st Street S.E. (Square 5318, Lot 164).

 - Applications for Party Status **must be filed with the Board 14 DAYS PRIOR** to the <u>originally</u> scheduled hearing date set forth in this letter.
