**BZA Application No. 20229**

The Board of Zoning Adjustment (Board or BZA) will consider the following application during the public hearing session scheduled for **Wednesday, March 25, 2020 beginning at 9:30 a.m.**, in the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4<sup>th</sup> Street, N.W., Suite 220 South, Washington, D.C., 20001:

**Application of David and Grace Kelly**, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under the penthouse requirements of Subtitle C § 1500.4, and under Subtitle C §1504.1 from the penthouse setback requirement of Subtitle C §1502.1 (c)(1)(A) and 1502.1 (c)(5), to construct a penthouse and guardrails on top of the third floor addition to an existing attached principal dwelling unit in the RF-1 Zone at premises 906 11th Street N.E. (Square 957, Lot 20).

**PLEASE NOTE REGARDING THE HEARING SCHEDULE:**

There is the possibility this case may be **RESCHEDULED OR WITHDRAWN** prior to the scheduled hearing date noted above. Those who wish to testify at the hearing are responsible for being present when their case is called. The published line-up of cases may change on the hearing day at the Board's discretion. Therefore, it is recommended that participants arrive at 9:30 a.m. to hear the case line up. Participants may also visit <https://dcoz.dc.gov/onlineServices/webcast> to listen to the live broadcast of the hearing starting at 9:30 a.m. to hear the case line-up and may listen periodically throughout the hearing to see which case the Board is hearing at any point in time.

**WHY YOU ARE RECEIVING THIS NOTICE**

An Applicant within 200 feet of your property is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia require providing notice of the public hearing at which the Applicant is scheduled to appear before the Board to present their case. You have an opportunity, if you wish, to participate in the case (see below).

## **HOW TO FAMILIARIZE YOURSELF WITH THE CASE**

### **A. Attend the Advisory Neighborhood Commission (ANC) Meeting**

The property in this case is located within the boundaries of **6A**. **6A** is an automatic party to the case and has been notified of the scheduled public hearing date. Please contact your ANC commissioner to learn how to participate in your ANC's deliberation process and to find out if or when the Applicant is scheduled to appear before the ANC. ### **B. Read Documents in the Record**

To review documents in the case, follow these steps:

- 1) Visit the Interactive Zoning Information System (IZIS) website at <https://dcoz.dc.gov/CaseRecord>.
- 2) Enter the BZA application number indicated above and click the search button.
- 3) The search results should produce the case on the right. Click "View Details".
- 4) Click "View Full Log".
- 5) This list comprises the full record in the case. Simply click "View" and it will open a PDF document in a separate window.

### **C. Speak with the Applicant/Applicant's Agent Directly**

For contact information on the Applicant or agent, please refer to the **Application Form** in IZIS (by following steps 1-5 above).

## **HOW TO PARTICIPATE IN THE CASE**

You have the option of participating in the case through one or more of the options below:

**A. Submit a statement into the record:** After reviewing the record, submit written testimony, either a letter in support, or a letter in opposition **before** the hearing.

- Upload your document to the case record in IZIS or, if you have technical difficulties with IZIS, send it as a PDF attachment by email to [bzasubmissions@dc.gov](mailto:bzasubmissions@dc.gov)
- **Electronic submissions sent after 9:00 A.M. on the morning of the hearing will not be accepted** into the record. Hard copy documents may be submitted to the case record by delivering in person at the time of the hearing when the case has been called by the Secretary.

**B. Attend the hearing and provide oral testimony** as a "person in support" or "person in opposition" at the hearing.

**C. Apply for Party Status** for more in depth involvement in the case.

- Upload a Party Status application (Form 140) to the case record in IZIS or send to [bzasubmissions@dc.gov](mailto:bzasubmissions@dc.gov)
- Applications for Party Status **must be filed with the Board 14 DAYS PRIOR** to the originally scheduled hearing date set forth in this letter.
