The Board of Zoning Adjustment (Board or BZA) will consider the following application during the public hearing session scheduled for <u>Wednesday</u>, <u>April 1</u>, <u>2020 beginning at 9:30 a.m.</u>, in the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001:

Application of 1777 Bond Street Equities LLC and Columbia Road of DC LLC, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under Subtitle C § 703.2, from the minimum parking requirement of Subtitle C § 701.5, to construct a 40 new residential units and ground level retail addition to an existing mixed-use building in the MU-5A Zone at premises 1767-1777 Columbia Road N.W. (Square 2580, Lot 522).

PLEASE NOTE REGARDING THE HEARING SCHEDULE:

 - Electronic submissions sent after 9:00 A.M. on the morning of the hearing will not be accepted into the record. Hard copy documents may be submitted to the case record by delivering in person at the time of the hearing when the case has been called by the Secretary.
- **B.** Attend the hearing and provide oral testimony as a "person in support" or "person in opposition" at the hearing.
- **C. Apply for Party Status** for more in depth involvement in the case.
 - Upload a Party Status application (Form 140) to the case record in IZIS or send to bzasubmissions@dc.gov
 - Applications for Party Status **must be filed with the Board 14 DAYS PRIOR** to the <u>originally</u> scheduled hearing date set forth in this letter.
