An Applicant within the boundaries of your ward is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on March 4, 2020 through the Interactive Zoning Information System (IZIS).

**Application of MQMF 1313 L Street LLC**, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under Subtitle I § 205.5 from the rear yard requirements of Subtitle I § 205, and pursuant to Subtitle X, Chapter 10, for an area variance from the court requirements of Subtitle I § 207.1, to redevelop an existing office building and convert it into a 10-story residential building in the D-4-R at premises 1313 L Street, N.W. (Square 247, Lot 94).
