REFERRAL MEMORANDUM AND NOTICE OF PUBLIC HEARING

Dear ANC Chair:

An Applicant within the boundaries of your ANC area is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on <u>May 11, 2020</u> through the Interactive Zoning Information System (IZIS).

A public hearing has been scheduled by the Board of Zoning Adjustment (Board) on <u>Wednesday</u>, <u>November 4, 2020 at 9:30 am</u>, virtually via WebEx, concerning the following application:

Application of Government Properties Income Trust LLC, pursuant to 11 DCMR Subtitle X, Chapter 9, for special exceptions under the penthouse restaurant use requirements of Subtitle C § 1500.3(c), and under the capitol security sub-area requirements of Subtitle I § 605.6, to renovate an existing office building into a mixed-use building in the D-3 Zone at premises 20 Massachusetts Avenue, N.W. (Square 626, Lot 78).
