The following Board of Zoning Adjustment (BZA) application has been scheduled for the Virtual Public Hearing session on <u>Wednesday</u>, <u>November 4, 2020 beginning at 9:30 a.m.</u> See page two for more details about accessing and participating in the virtual hearing via Webex and telephone.

**Application of 4865 MacArthur Landlord, LLC**, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under the use provisions of Subtitle U § 203.1(g), to establish a continuing care retirement community in the R-1-B and MU-4 Zones at premises 4865 MacArthur Boulevard, N.W. (Square 1389, Lot 25).

#### WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.

## PLEASE NOTE REGARDING THE HEARING SCHEDULE:

There is the possibility that cases may be **RESCHEDULED OR WITHDRAWN** prior to the scheduled virtual hearing date noted above. - B. Sign up to provide testimony at the virtual hearing:
  - To provide oral comments during a virtual hearing, <u>participants are strongly encouraged to sign up at least 24 hours before the hearing</u> in order to be heard.

- **C. Submit a statement into the record:** After reviewing the record, submit written testimony, either a letter in support, or a letter in opposition. Submissions are <u>required to be sent at least 24 hours before</u> the hearing.
  - Upload your document to the case record in IZIS or, if you have technical difficulties with IZIS, send it as a PDF attachment or include the statement in the body of the email to <a href="mailto:bzasubmissions@dc.gov">bzasubmissions@dc.gov</a>.
  - Hard copies of documents will not be accepted at this time.
