

Application of Foundation to Support Animal Protection, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exceptions under the lodging use requirements of Subtitle U § 504.1(f), to renovate the interior of the building to accommodate space for 10 guests in the existing office building in the MU-15 Zone at premises 1536 16th Street N.W. (Square 180, Lot 42).

WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case. The Regulations also require that notification of the public hearing be provided to property owners_within_200_feet_of_the subject property indicated in the application, based on DC Office of Tax and Revenue records.

PLEASE NOTE REGARDING THE HEARING SCHEDULE:

There is the possibility that cases may be **RESCHEDULED OR WITHDRAWN** prior to the scheduled virtual hearing date noted above.
