## **REFERRAL MEMORANDUM AND NOTICE OF PUBLIC HEARING**

Dear ANC Chair:

An Applicant within the boundaries of your ANC area is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on <u>August 21</u>, <u>2020</u> through the Interactive Zoning Information System (IZIS).

A public hearing has been scheduled by the Board of Zoning Adjustment (Board) on <u>Wednesday</u>, January 13, 2021 at 9:30 am, virtually via WebEx, concerning the following application:

**Application for Mary's House for Older Adults, Inc.,** pursuant to 11 DCMR Subtitle X, Chapter 9 for special exceptions under the use provisions of Subtitle U § 203.1(g), under Subtitle D § 5201 from the lot occupancy requirement of Subtitle D § 304.2, the side yard requirement of Subtitle D § 307.4, and pursuant to Subtitle X, Chapter 10, for an area variance from the driveway width requirements of Subtitle C § 711.6, and the use requirements of Subtitle U § 203.1(g)(2), to replace an existing principal dwelling unit with a continuing care retirement community for 15 individuals in the R-3 Zone at premises 401 Anacostia Road, SE (Parcel 0203/0009).

- Click "View Full Log".
- This list comprises the full record in the case. Simply click "View" on any document you wish to see, and it will open a PDF document in a separate window.

As described in the Zoning Regulations of the District of Columbia (Regulations), the affected ANC is an automatic party to the case and the Board gives "great weight" to its written report.

Though ANC reports may be filed at any time prior to the Board's final deliberation on the case, the ANC is strongly encouraged to submit their report no later than <u>seven days</u> prior to the public hearing date so that the Board has ample time to consider the ANC's position.

#### HOW TO PARTICIPATE IN THE VIRTUAL HEARING AND/OR SUBMIT COMMENTS:

#### A. Watch/listen to the hearing:

- B. Sign up to provide testimony at the virtual hearing:
  - To provide oral comments during a virtual hearing, **<u>participants are strongly encouraged</u>** to sign up at least 24 hours before the hearing in order to be heard.

- **C.** Submit a statement into the record: After reviewing the record, submit written testimony, either a letter in support, or a letter in opposition. Submissions are <u>required to be sent at least 24 hours</u> <u>before the hearing</u>.
