REFERRAL MEMORANDUM AND NOTICE OF PUBLIC HEARING

Dear ANC Single Member District Commissioner:

An Applicant within the boundaries of your ANC Single Member District is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on <u>August 21, 2020</u> through the Interactive Zoning Information System (IZIS).

A public hearing has been scheduled by the Board of Zoning Adjustment (Board) on <u>Wednesday</u>, <u>January 13, 2021 at 9:30 am</u>, virtually via WebEx, concerning the following application:

Application for Mary's House for Older Adults, Inc., as amended, pursuant to 11 DCMR Subtitle X, Chapter 9 for a special exception under the use provisions of Subtitle U § 203.1(g), and pursuant to Subtitle X, Chapter 10, for a use variance from the use requirements of Subtitle U § 203.1(g)(2), and area variances from the driveway width requirements of Subtitle C § 711.6, the side yard requirements of Subtitle D § 206.2, and from the lot occupancy requirements of Subtitle D § 304.1, to replace an existing principal dwelling unit with a continuing care retirement community for 15 individuals in the R-3 Zone at premises 401 Anacostia Road, SE (Parcel 0203/0009).
