Good Morning,

I hope this finds you well. We recently filed three new BZA Applications that are alley lots. 782 Fairmont Street, NW (BZA Case No. 20346) & 921 Euclid Street, NW (BZA Case No. 20347) are applications for special exception relief to put a single-family home on each alley lot. The alley directly in front of the properties is 15 ft. wide, but the entrances to the alley are only 10 feet, so we need relief. The hearing date for these two cases is on December 23rd.

Lastly, 514 Archibald Walk, SE (<u>BZA Case No. 20363</u>) is not 300 linear feet from the street. Therefore, we need special exception relief to use the building as a single-family dwelling. The hearing date for this case is on January 27th.
