#### REFERRAL MEMORANDUM AND NOTICE OF PUBLIC HEARING

Dear ANC Single Member District Commissioner:

An Applicant within the boundaries of your ANC Single Member District is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on <u>September 8, 2020</u> through the Interactive Zoning Information System (IZIS).

A public hearing has been scheduled by the Board of Zoning Adjustment (Board) on **Wednesday**, **February 3, 2021 at 9:30 am**, virtually via WebEx, concerning the following application:

**Application of Lee A. Granados and Kevin R Klym**, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under Subtitle F § 5201, from the lot occupancy requirements of Subtitle F § 604.1, to construct a new porch addition with entry stairs, to an existing attached principal dwelling unit in the RA-8 Zone at premises 1725 Church Street NW (Square 156, Lot 337).

## A. Watch/listen to the hearing:

### **B.** Sign up to provide testimony at the virtual hearing:
