#### REFERRAL MEMORANDUM AND NOTICE OF PUBLIC HEARING

#### Dear Councilmember:

An Applicant within the boundaries of your ward is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on <u>September 4, 2020</u> through the Interactive Zoning Information System (IZIS).

A public hearing has been scheduled by the Board of Zoning Adjustment (Board) on <u>Wednesday</u>, <u>February 3, 2021 at 9:30 am</u>, virtually via WebEx, concerning the following application:

**Application of Charles and Coreil Dickinson,** pursuant to 11 DCMR Subtitle X, Chapter 9, for special exceptions under Subtitle E §§ 205.5 and 5201, from the rear addition requirements of Subtitle E § 205.4, the lot occupancy requirements of Subtitle E § 304.1, and the rear yard requirements of Subtitle E § 306.1, to construct a three-story rear addition and a third floor addition to an existing principal dwelling unit in the RF-1 Zone at premises 1507 E Street SE (Square 1076, Lot 38).

### **HOW TO PARTICIPATE IN THE CASE**

If you wish to participate in the case, you may submit a letter in support or opposition into the record, or appear as a witness to testify at the public hearing. Visit the Interactive Zoning Information System (IZIS) on our website at <a href="https://app.dcoz.dc.gov/Login.aspx">https://app.dcoz.dc.gov/Login.aspx</a> to make a submission. You will need to create a username and password if you have not done so already.

# HOW TO PARTICIPATE IN THE VIRTUAL HEARING AND/OR SUBMIT COMMENTS:

# A. Watch/listen to the hearing:

- Members of the public can watch and listen to the public hearing via Webex or YouTube Live, or they can listen to the audio of the hearing by calling via telephone.

## **B.** Sign up to provide testimony at the virtual hearing:

- **C. Submit a statement into the record:** After reviewing the record, submit written testimony, either a letter in support, or a letter in opposition. Submissions are <u>required to be sent at least 24 hours before the hearing.</u>
  - Upload your document to the case record in IZIS or, if you have technical difficulties with IZIS, send it as a PDF attachment or include the statement in the body of the email to <a href="mailto:bzasubmissions@dc.gov">bzasubmissions@dc.gov</a>.
  - Hard copies of documents will not be accepted at this time.
