# **HOW TO PARTICIPATE IN THE VIRTUAL HEARING AND/OR SUBMIT COMMENTS:**

### A. Watch/listen to the hearing:

## **B.** Sign up to provide testimony at the virtual hearing:

- **C.** Submit a statement into the record: After reviewing the record, submit written testimony, either a letter in support, or a letter in opposition. Submissions are <u>required to be sent at least 24 hours before the hearing</u>.
  - Upload your document to the case record in IZIS or, if you have technical difficulties with IZIS, send it as a PDF attachment or include the statement in the body of the email to <a href="mailto:bzasubmissions@dc.gov">bzasubmissions@dc.gov</a>.
  - Hard copies of documents will not be accepted at this time.
