If you wish to participate in the case, you may submit a letter in support or opposition into the record, or appear as a witness to testify at the public hearing. Visit the Interactive Zoning Information System (IZIS) on our website at <u>https://app.dcoz.dc.gov/Login.aspx</u> to make a submission. You will need to create a username and password if you have not done so already.

HOW TO PARTICIPATE IN THE VIRTUAL HEARING AND/OR SUBMIT COMMENTS:

 - Hard copies of documents will not be accepted at this time.
