# BZA Application No. 20541 1899 Penn Property, LLC 1899 Pennsylvania Avenue, NW (Square 105, Lot 843)

### **SUMMARY ORDER**

<u>RELIEF REQUESTED.</u> The application requests the following relief in order to construct a new penthouse addition to an existing, semi-detached, commercial use building in the D-6 Zone:

• Special exception under the penthouse use requirements of Subtitle C § 1501.1(e), pursuant to Subtitle X § 901

The zoning relief requested in this case was self-certified. (Exhibit 28A (Final Revised); Exhibit 3 (Original).)<sup>2</sup>

<u>PARTIES</u>. The parties to this case were the Applicant and Advisory Neighborhood Commission ("ANC") 2B and 2A, the "affected ANCs" pursuant to Subtitle Y §§ 101.8 and 403.5(b) of the Zoning Regulations (Title 11 of the DCMR, Zoning Regulations of 2016, to which all references are made unless otherwise specified).

**NOTICE OF THE APPLICATION AND PUBLIC HEARING.** The Board of Zoning Adjustment (the "**Board**") referred the application to the appropriate agencies and provided proper and timely notice of the public hearing in accordance with Subtitle Y § 402.1.

ANC REPORT. The ANC's report indicated that at a regularly scheduled, properly noticed public meeting on October 13, 2021, at which a quorum was present, the ANC voted to support the application. (Exhibit 29.) The ANC report raised no issues or concerns.

<u>OFFICE OF PLANNING ("OP") REPORT.</u> OP submitted a report recommending approval of the application. (Exhibit 30.)

<u>DISTRICT DEPARTMENT OF TRANSPORTATION ("DDOT") REPORT.</u> DDOT submitted a report indicating that it had no objection to the application because it concluded that the relief would not result in any adverse impacts to the District's transportation network. (Exhibit 31.)

<u>U.S. SECRET SERVICE</u>. The Secret Service submitted a letter stating they had no objections to the proposed project. (Exhibit 28B.)

#### **CONCLUSIONS**

Pursuant to Subtitle Y § 604.3, the order of the Board may be in summary form where granting an application when there was no party in opposition. As a summary order, it does not constitute binding legal precedent on the Board and shall not be considered by the Board in evaluating future applications.

Based upon the record before the Board, and having given great weight to the appropriate reports and recommendations filed in this case, the Board concludes that the Applicant has met the burden of proof that the requested special exception relief can be granted because:

- It is in harmony with the general purpose and intent of the Zoning Regulations and Map;
- It will not tend to affect adversely the use of neighboring property; and
- Pursuant to Subtitle X § 901.2(c), the relief satisfies the specified conditions for special exception relief.

# **DECISION**

Based on the case record and the testimony at the hearing, the Board concludes that the applicant has satisfied the burden of proof for the requested relief and therefore **APPROVES** the following relief:

• Special exception under the penthouse use requirements of Subtitle C § 1501.1(e), pursuant to Subtitle X § 901

Subject to the following **CONDITION**:

1. The project shall be constructed in accordance with the plans submitted as Exhibit 28C in the record,<sup>3</sup> as required by Subtitle Y §§ 604.9 and 604.10.

<sup>&</sup>lt;sup>3</sup> <u>Self-Certification</u>. The zoning relief requested in this case was self-certified, pursuant to Subtitle Y § 300.6. In granting the requested self-certified relief subject to the plans submitted with the Application, the Board makes no finding that the requested relief is either necessary or sufficient to authorize the proposed construction project described in the Application and depicted on the approved plans. Instead, the Board expects the Zoning Administrator to undertake a thorough and independent review of the building permit and certificate of occupancy applications filed for this project and to deny any such application that would require additional or different zoning relief from what is granted by this Order.

PURSUANT TO SUBTITLE Y § 703.14, NO OTHER ACTION, INCLUDING THE FILING OR GRANTING OF AN APPLICATION FOR A MODIFICATION PURSUANT TO SUBTITLE Y §§ 703 OR 704, SHALL TOLL OR EXTEND THE TIME PERIOD.

PURSUANT TO 11 DCMR SUBTITLE Y § 604, APPROVAL OF AN APPLICATION SHALL INCLUDE APPROVAL OF THE PLANS SUBMITTED WITH THE APPLICATION FOR THE CONSTRUCTION OF A BUILDING OR STRUCTURE (OR ADDITION THERETO) OR THE RENOVATION OR ALTERATION OF AN EXISTING BUILDING OR STRUCTURE.
