# **B.** Sign up to provide testimony at the virtual hearing:

- **C. Submit a statement into the record:** After reviewing the record, submit written testimony, either a letter in support, or a letter in opposition. Submissions are <u>required to be sent at least 24 hours</u> before the hearing.

- Hard copies of documents will not be accepted at this time.
