The Applicant hereby files a Motion for Clarification/Reconsideration of the Conditions of BZA Order No. 20643, dated April 12, 2023. This Motion is made pursuant to Subtitle Y, Section 700.2 of the Zoning Regulations.

The Findings of Fact and Conclusions of Law and Opinion of BZA Order No. 20643 clearly and unequivocally address the application's satisfaction of the Special Exception standards for the requested relief. This request relates solely to the Applicant's interest that the proposed restrictions and limitations of the use and design of the athletic facilities delineated in the application are specifically articulated in the order so as to be fully enforceable. To ensure that the proposed restrictions and limitations of the use and design of the athletic facilities delineated in the application are clearly articulated as fully enforceable conditions of approval that can be easily discerned by the Office of the Zoning Administrator of the Department of Buildings, the Applicant requests the inclusion of additional conditions in BZA Order No. 20643.

EXHIBIT A

The Applicant proposes the following conditions be added to BZA Order No. 20643:

- 5. Goal posts shall be removable and shall only be in place from August until the Applicant's last football game of the season.
- 6. The Applicant shall construct a security fence around the perimeter of the property and shall prohibit players and spectators from accessing the adjacent alleys or properties from the playing fields.
- 7. The protective netting shall be no taller than 30 feet, measured from the finished grade adjacent to its immediate location.
- 8. The Applicant shall use moveable bleachers at the multipurpose field. No bleacher set shall exceed 6 tiers. Spectators shall be encouraged to sit in the bleachers and discouraged from standing on the sidelines.
- 9. The Applicant shall not propose, nor shall it allow, the installation or use of lights to illuminate the multi-purpose athletic field or the baseball diamond. The fields shall not be used at any time after dusk. Down-lit security lighting shall be limited to the parking lot area. The lights shall be no higher than 12 feet and shall be fully down-lit. Lights shall use a combination of photocell and timer so that they are on only when dark and go off no later than 9:00 p.m. Security motion lights shall be permitted on the fieldhouse building.
- 10. The proposed scoreboard shall be limited to a height of no more than 20 feet, measured from the finished grade adjacent to its immediate location.
- 11. The Applicant shall only be permitted to lease the fields to youth sports organizations based in the District of Columbia and may charge a reasonable fee for use of the fields. For any leased use of the fields, the total number of players and coaches shall not exceed 60 at any time, with the exception of summer camps during which the total number of participants and staff shall not exceed 75 in any session, with at least 30 minutes between sessions.
- 12. Use of the athletic facilities shall not exceed the hours as set forth below:
 - i. Pre-Season (mid to late August):
 - Monday: 8:00 a.m. to 6:00 p.m.
 - Tuesday: 8:00 a.m. to 6:00 p.m.

The Applicant shall make the athletic facilities available for scheduled use by children attending ECC and District of Columbia Public School (DCPS) traditional and charter schools on weekdays during the academic school year between the hours of 9:00 a.m. and 3:00 p.m. on Monday, Tuesday, Thursday and Friday and between the hours of 9:00 a.m. and 2:00 p.m. on Wednesday. The Applicant shall limit any fees charged for such use by DCPS traditional and charter school students to the rates charged for athletic field use by DPR.
- 15. The Applicant shall post on its website for the athletic facilities the hours of seasonal uses of the athletic field by the Applicant or others as set forth in these conditions and will provide a link to the Applicant's athletic schedule.
- 16. On weekdays during the academic year, the parking lot and field gates shall be open and/or unlocked during daylight hours to allow access to authorized users. During periods when the athletic facilities are not scheduled for use, the Applicant may secure the parking lot and/or field gates. Community members shall be provided with a means to access the field (e.g., by a gate code) in the event the field gate is locked during a period of time when community use is permitted. During all times of the year, the parking lot and field gates shall be locked from dusk until dawn.
