SUMMARY ORDER

<u>RELIEF REQUESTED.</u> The application requests the following relief in order to construct a new, detached, three-story, with cellar and penthouse, 24-unit, apartment house in the RA-1 zone:

• Special exception from the matter-of-right uses of Subtitle U \S 401, pursuant to Subtitle U \S 421 and Subtitle X \S 901.2

The zoning relief requested in this case was self-certified. (Exhibit 35 (Final Revised); Exhibit 32 (1st Revised); Exhibit 3 (Original).)²

<u>PARTIES</u>. The parties to this case were the Applicant and Advisory Neighborhood Commission ("ANC") 5C, the "affected ANC" pursuant to Subtitle Y §§ 101.8 and 403.5(b) of the Zoning Regulations (Title 11 of the DCMR, Zoning Regulations of 2016, to which all references are made unless otherwise specified).

NOTICE OF THE APPLICATION AND PUBLIC HEARING. The Board of Zoning Adjustment (the "**Board**") referred the application to the appropriate agencies and provided proper and timely notice of the public hearing in accordance with Subtitle Y § 402.1.

ANC REPORT. The ANC's report indicated that at a regularly scheduled, properly noticed public meeting on March 16, 2022, at which a quorum was present, the ANC voted to support the application. (Exhibit 28.) The ANC report raised no issues or concerns. ANC 5C02 Commissioner Lauren Rogers testified on behalf of the ANC at the Public Hearing.

OFFICE OF PLANNING ("OP") REPORT. OP submitted two reports to the record:

- The original OP report, dated March 18, 2022, requested additional information and indicated that OP was unable to make a recommendation at that time. (Exhibit 19.)
- The supplemental OP report, dated April 14, 2022, recommended approval of the application. (Exhibit 34.) OP noted the proposed lot occupancy listed in the self-

certification form was over the 40% maximum allowed by right; the Applicant subsequently submitted a revised self-certification form (Exhibit 35) updating the proposed lot occupancy to comply with the regulations.

<u>DISTRICT DEPARTMENT OF TRANSPORTATION ("DDOT") REPORT.</u> DDOT submitted a report indicating that it had no objection to the application because it concluded that the relief would not result in any adverse impacts to the District's transportation network. (Exhibit 20.) DDOT recommended the Board adopt conditions relating to transportation demand management, landscaping, public space, and the proposed curb cut. The Board understood that the Applicant agreed to implement the DDOT conditions and did not adopt them as conditions of the order.

<u>Persons in Opposition</u>. The Board received one letter from a neighbor in opposition to the application. (Exhibit 27.)

CONCLUSIONS

Pursuant to Subtitle Y § 604.3, the order of the Board may be in summary form where granting an application when there was no party in opposition. As a summary order, it does not constitute binding legal precedent on the Board and shall not be considered by the Board in evaluating future applications.

Based upon the record before the Board, and having given great weight to the appropriate reports and recommendations filed in this case, the Board concludes that the Applicant has met the burden of proof that the requested special exception relief can be granted because:

- It is in harmony with the general purpose and intent of the Zoning Regulations and Map;
- It will not tend to affect adversely the use of neighboring property; and
- Pursuant to Subtitle X § 901.2(c), the relief satisfies the specified conditions for special exception relief.

DECISION

Based on the case record and the testimony at the hearing, the Board concludes that the applicant has satisfied the burden of proof for the requested relief and therefore **APPROVES** the following relief:

 Special exception from the matter-of-right uses of Subtitle U § 401, pursuant to Subtitle U § 421 and Subtitle X § 901.2

Subject to the following **CONDITION**:

1. The project shall be constructed in accordance with the plans submitted as Exhibit 31 in the record,³ as required by Subtitle Y §§ 604.9 and 604.10.

³ <u>Self-Certification</u>. The zoning relief requested in this case was self-certified, pursuant to Subtitle Y § 300.6. In granting the requested self-certified relief subject to the plans submitted with the Application, the Board makes no finding that the requested relief is either necessary or sufficient to authorize the proposed construction project described in the Application and depicted on the approved plans. Instead, the Board expects the Zoning Administrator
