Hi everyone,

First of all, thank you for your quick action regarding our comments on the speed bump proposal. They have been installed & seem to be calming traffic on our block. We appreciate it!

Secondly, several neighbors and I have new concerns about something close to home: zoning for case number 21103 for Developer REI, LLC. We have been informed of the upcoming meeting for planning on March 24th related to the new development on the NW corner of 1st and Kennedy St. NW. The proposal for that development is not as advertised to us nearly six years ago. Originally it included ground floor businesses that would have added to our community & enhanced Kennedy Street. Now the developer seeks to install only apartments with no retail.

We are deeply concerned. In the span of less than 24 hours, we have organized strong support from many residents of the neighborhood. Every neighbor we've been in contact with prefers including retail or restaurant businesses in the development. We will continue to reach out to neighbors about this to collect more support. We beg that you take every action to block any permitting that will not include businesses. You can see our petition here:

In the recommendations I made, it was noted that:

The speed hump slated for 1st Street should be spaced out to include the 5600 block of 1st Street NW. If speed humps are only on the 5700 block, the kids would likely just make it a two-block loop rather than three block loop and the problem will not be solved.

A copy of this and all recommendations for the traffic calming measures within ANC 4B06 were copied to Commissioner Brooks.

It will be up to Commissioner Brooks to determine the next steps regarding the 5600 block which is in her single-member district.
