What is "Out of Order"? Any activity that is called 'out of order' by the Chairperson is done so because it violates one of the process rules outlined in the Parliamentary Procedure document above. The most common infractions are:

- Interrupting a meeting by speaking when not recognized
- Not adhering to speaker or discussion time requirements
- Attempting to do something that violates ANC 4C's policies such as 48 hour notice to submit documents to be voted on, or District law
