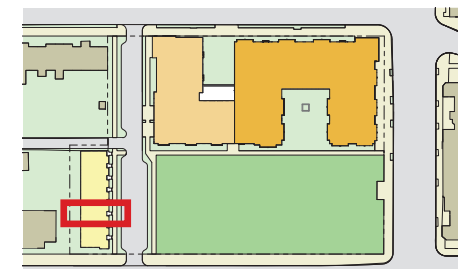
1st Floor Plan

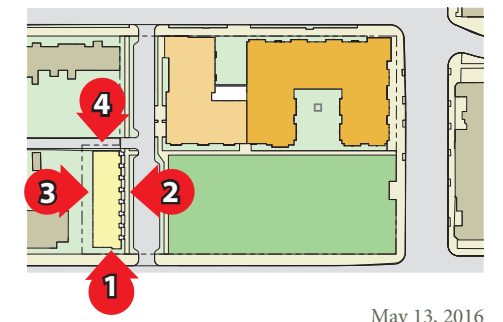

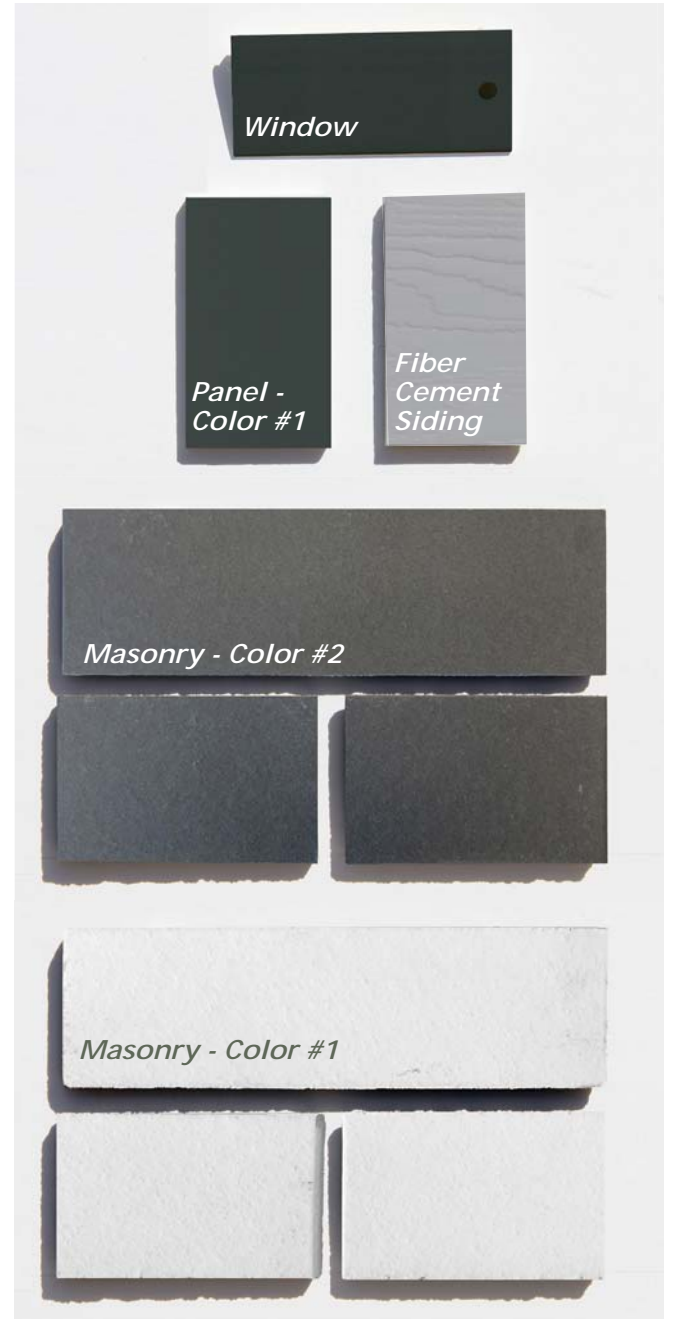

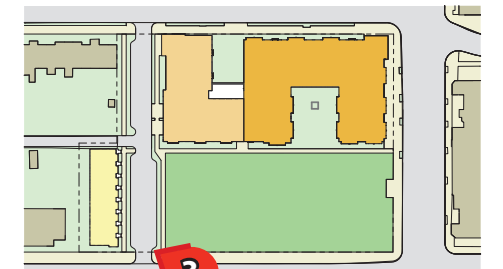
