On behalf of the Applicant, enclosed please find two copies of an application for consolidated approval of a Planned Unit Development ("PUD") and related Zoning Map Amendment for the above-referenced Property, along with ten copies of the plans. The proposed PUD and map amendment will facilitate the redevelopment of the Property into a mixed-use retail/residential project along Wisconsin Avenue.

The Application was filed electronically through the Interactive Zoning Information System (IZIS) on November 21, 2016.
