

**BFTAA Petition for Review**

The order for Zoning Commission case no. 14-02 became "final May 29, 2015". Zoning Commission Order No. 14-02, 68. According to municipal regulation 11-3029.5 a motion for reconsideration "may be filed by a party within ten (10) days of the order having become final." Petitioners filed a motion for reconsideration June 8, 2015. Board of Zoning Commissioners ruled on the motion for reconsideration June 29th, 2015, denying Petitioners motion for reconsideration. July 28th, 2015 BFTAA filed a petition for Review with the Court of Appeals. July 30th, 2015 the Board of Zoning Commissioners served the parties notice that a written order was issued on the June 8th, 2015 motion for reconsideration. This order was published August 14th, 2015.

Pursuant to rule Rule 15(b) and Rule 15(a) 2 Petitioners have 30 days to file a petition for appeal after an agency makes a final ruling on a motion for

reconsideration. Petitioners hereby move to dismiss without prejudice the petition filed July 28, 2015, which was not ripe for appeal and thus far has not been assigned a case number, and moves to re-file with the foregoing petition on behalf of the Barry Farm Tenants and Allies Association (BFTAA), which was granted party status in the aforementioned contested case.
