On behalf of the Applicant, enclosed please find two copies of an application for consolidated approval of a Planned Unit Development ("PUD") and related Zoning Map Amendment for the above-referenced Property, along with ten copies of the plans. The proposed PUD and map amendment will facilitate the redevelopment of the Property into a residential development consisting of one detached single-family home and five row houses, as well as the conversion of a historic building to a single family house.

The Application was filed electronically through the Interactive Zoning Information System (IZIS) on November 20, 2017. The application packages filed online and enclosed herein meet the filing requirements detailed in Subtitle Z, Chapter 3 of the Zoning Regulations, and include the completed application forms, copy of the notice of intent to file the PUD that was mailed to surrounding property owners and parties (with certification of mailing and list of property owners), detailed architectural drawings, plans, and elevations of the proposed project (which include photographs of the existing property), and a map depicting the current and proposed Zone Districts for the property and surrounding area.

Also attached to this letter are two sets of preprinted labels for the surrounding property owners and parties, and a check for \$1,300 which represents the filing fee in this matter.
