Petition summary and background	Meridian International Center has teamed up with a developer to turn their leafy lot on 16th Street into a nine-story luxury apartment building and conference center. This project will lead to increased congestion, traffic, and the destruction of dozens of mature and heritage trees. Despite overwhelming community opposition, including several unanimous resolutions by the ANC, which is legally entitled to "great weight" consideration by D.C. agencies, the powers that be in D.C. government have approved this project.
