
The Chevy Chase Advisory Neighborhood Commission (ANC 3/4G) hereby informs the Zoning Commission that ANC 3/4G's party status request relating to Case No 02-17 cannot be filed by November 1 (14 days in advance of the hearing) due to an emergency beyond the Commission control. We ask, therefore, that ANC 3/4G's party status submittal be waived into the record.

ANC 3/4G schedule and advertised Stonebridge Associates' presentation on the Washington Clinic/Lisner Home site for its Monday, October 28, 2002 public meeting to be held at 7:30 p.m. at the Chevy Chase Community Center. Late Monday morning, the Commission was notified that the Community Center would close at 5:00 pm that day due to a major plumbing problem. The ANC's public meeting and Stonebridge's presentation has been rescheduled for Monday, November 4, 2002.

The ANC's party status submittal will be reviewed and voted on at the November 4, public meeting and will be transmitted to the Zoning Commission no later that November 7.

For the record, I have been authorized to prepare and sign the Commission's waver appeal to the Zoning Commission.
