The Office of the Deputy Mayor for Planning and Economic Development (ODMPED) strongly supports the pending Planned Unit Development Application for the redevelopment of the Waterside Mall by Waterfront Associates, LLC. This project, with the relocation of the Department of Consumer and Regulatory Affairs (DCRA) and the Office of the Chief Financial Officer (OCFO) to the 2 new office structures known as 4<sup>th</sup> Street West and 4<sup>th</sup> Street East, will be a powerful catalyst for economic revitalization of this neighborhood.

In addition to the two Agencies relocating to Southwest, ODMPED and the District Department of Transportation (DDOT) are negotiating the execution of an agreement for the reconstruction and re-opening of 4<sup>th</sup> Street, SW through the site. Furthermore, the road and sidewalk ROW will be built using the Anacostia Waterfront Initiative Standards.
