I am a sophomore at the George Washington University and I am writing to you to urge you to allow the renovations planned for Thurston Hall on GW's campus. On-campus, I am involved in Residence Life as I am a Hall Council Advisor for Residence Hall Association, a representative organization that is composed of 27 hall councils, one per each residence hall. Our organization's main goal is to "make every hall a home" as we seek to advocate for residents and build community within our halls.

The most pressing issue that in Thurston right now is that it is overpopulated. Over 1,000 students are crammed into the building, living in rooms of up to 6 people. This has made many first-year students uncomfortable and creates an unfavorable first-year experience. This issue is directly addressed with the new floor plans for Thurston, which, reduces the population down to 825 students in only single and double units. This will greatly enhance the first-year experience and help students feel more comfortable when moving in their freshman year.

Another on-campus issue that is addressed with the Thurston Renovation is an overwhelming lack of community space on our campus. Most residence halls on our campus have little to no space for the community to come together. This has lead to a lack of community on campus which makes the residential experience unfulfilling for our students. With more space for residents to come together, it can make a major impact on a student's experience, especially their first year. Looking back, I wish I had the space that the renovations would give.
