### THIS CASE IS OF INTEREST TO ANC 6D

On April 4, 2007, the Office of Zoning received an application from Forest City SEFC, LLC, on behalf of the U.S. General Services Administration (the "applicant") for approval of a map and text amendment to the Southeast Federal Center Overlay District.

The property that is the subject of this application consists approximately of Squares 771, 802, and parts of Squares 801, 803, 826, 827, and 853. The site is bounded on the north by M Street S.E. and the newly constructed U.S. Department of Transportation Headquarters Building, on the east by Isaac Hull Avenue, S.E. and the Navy Yard, to the south by the Anacostia River, and on the west by 1<sup>st</sup> Street S.E. and the Water and Sewer Authority Pumping Station.
