



5. The placard shown in photograph #5 is located on 2nd Street, SE.

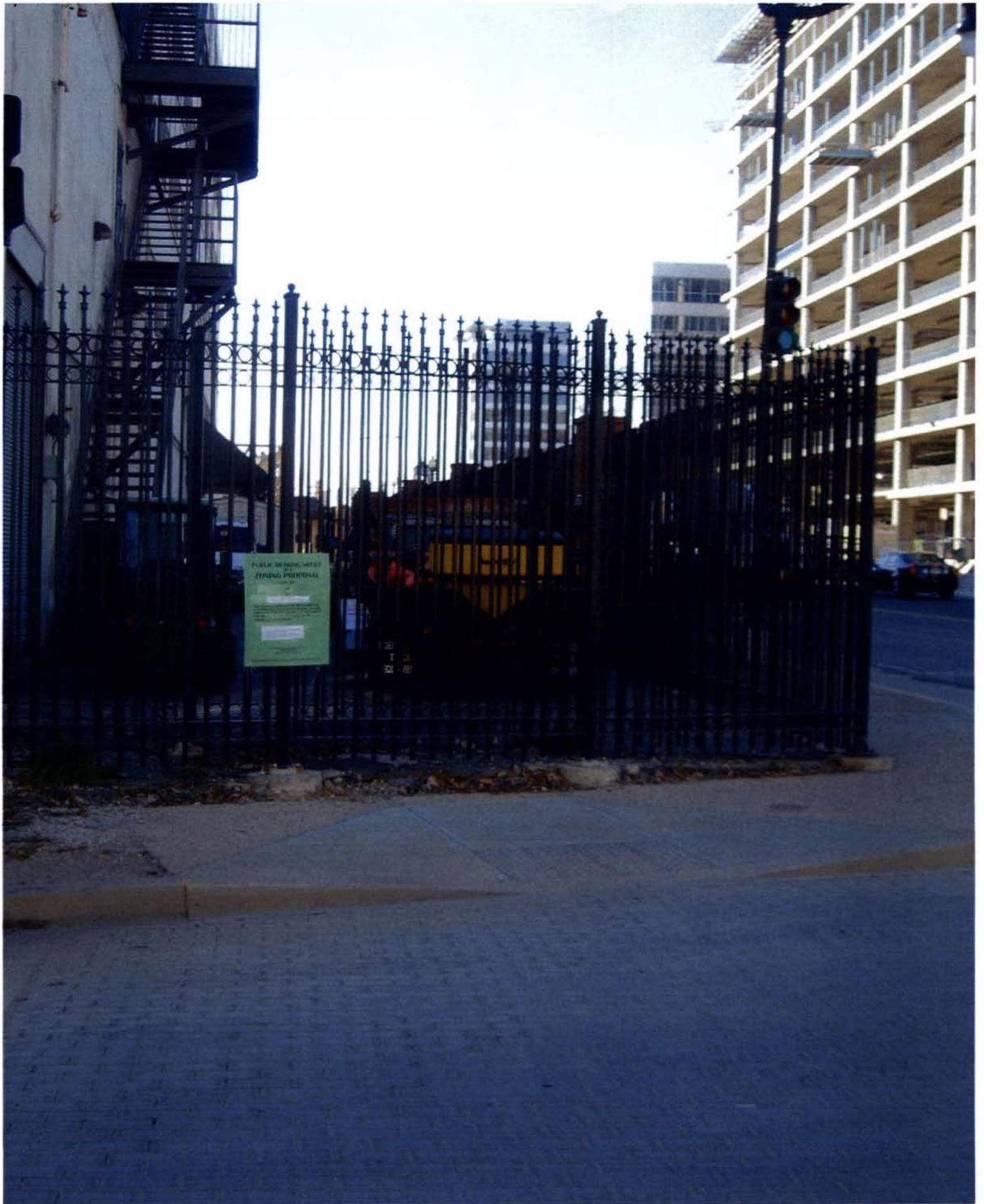
