Case No. 07-19 – Text Amendment to Repeal of 11 DCMR § 411.10

THIS CASE IS OF INTEREST TO ALL ANCS

The Office of Planning, through its report dated June 29, 2007 proposed a repeal of 11 DCMR § 411.10, which requires that the Zoning Administrator submit roof structure plans to the Office of Planning for its review and report within fifteen (15) days.¹ The Office of Planning Report indicated that the intent is to address unintended delays in the permitting process due to the increase in the volume of development projects submitted to the Department of Consumer and Regulatory Affairs (DCRA). This action does not alter the authority of the Zoning Administrator in referring actions to the Board of Zoning Adjustment if roof structure requirements are not met. The Office of Planning's report served as the pre-hearing submittal for the case.

The Zoning Commission set the case down for a public hearing at its regularly scheduled public meeting held on July 9, 2007 and authorized the scheduling of this hearing 30 days after the publication of this notice.

The public hearing on this case will be conducted as a rulemaking in accordance with the provisions of Section 3021 of the District of Columbia Municipal Regulations, Title 11, Zoning. Pursuant to that section, the Commission will impose time limits on testimony presented to it at the public hearing.

All individuals, organizations, or associations wishing to testify in this case should file their intention to testify in writing. Written statements, in lieu of personal appearances or oral presentations, may be submitted for inclusion in the record.
