ZONING COMMISSION FOR THE DISTRICT OF COLUMBIA NOTICE OF PROPOSED RULEMAKING

ZC Case No. 07-19 (Text Amendment – 11 DCMR) Repeal of 11 DCMR § 411.10

The Zoning Commission for the District of Columbia, pursuant to its authority under §§ 1 and 8 of the Zoning Act of 1938, approved June 20, 1938 (52 Stat. 797, as amended; D.C. Code 2001 Ed. § 6-641.01 (2001)), hereby gives notice of its intent to amend Chapter 4 of the Zoning Regulations (Title 11 of the District of Columbia Municipal Regulations (DCMR)) by repealing § 411.10. 1

Final rulemaking action shall be taken in not less than thirty (30) days from the date of publication of this notice in the D.C. Register and not prior to its completion of its hearing on the petition and the conclusion of the thirty day period of review by the National Capital Planning Commission.

The proposed amendment would repeal the requirement that the Zoning Administrator submit roof structure plans to the Office of Planning for its review and report within fifteen (15) days of the submission.

The following rulemaking action is proposed:

Amend 11 DCMR to repeal § 411.1.

All persons desiring to comment on the subject matter of this proposed rulemaking action should file comments in writing no later than thirty (30) days after the date of publication of this notice in the D.C. Before taking final action on a roof structure plan, the Zoning Administrator shall submit the plan to the D.C. Office of Planning from review and report. The report shall be returned within fifteen (15) days of the date of submission unless a different period has been provided by mutual agreement of all parties involved.
