On behalf of the Applicant for the above-referenced application, we hereby submit the following information that was specifically requested by the Commission during the course of the limited scope public hearings held on March 23, April 6, April 19, and May 1, 2017.

- · Map showing Census Tract boundaries for North and South Bloomingdale (Exhibit A).
- Additional information regarding Washington, D.C. office market vacancy and common healthcare facility floor heights and equipment precedents presented by the Applicant's witness, Mr. Adam Weers, at the April 19, 2017, limited scope public hearing (Exhibit B).
- · Overall floor-area-ratio ("FAR") calculations for each of the masterplan alternatives previously considered by the Applicant that were presented by the Applicant's witness, Mr. Matthew Bell, at the April 19, 2017, limited scope public hearing (Exhibit C).

In addition to the information described above, which was specifically requested by the Commission during the course of the aforementioned limited scope public hearings, the Applicant also submits full versions of the Land Development Disposition Agreements ("LDDA") that have been approved by the D.C. The Applicant submits these full versions of the Council approved LDDAs in response to the motion in limine filed by Friends of McMillan Park ("FOMP"), party in opposition, on May 1, 2017, which included as Exhibit C a portion of one of the LDDA packages. See Z.C. Case No. 13-14, Exhibit 942C. In response to FOMP's motion, the Applicant did not object to FOMP's submission of the documents attached to its motion, but reserved its right to supplement the record with complete versions of the LDDA packages. See Z.C. Case No. 13-14, Exhibit 943. At the outset of the May 1, 2017, limited scope public hearing, the Commission agreed to allow
