25	the Council a request for approval of five (5) additional years of time, amounting to seven
26	(7) years total, for the disposition of certain real property located 2501 First Street, N.W.,
27	and comprising of approximately 1,075,496 square feet of land, designated for purposes
28	of taxation and assessment as Lot 0800 in Square 3128 ("McMillan Site"), in which
29	disposition was approved by the Council pursuant to the McMillan Residential
30	Townhomes Parcel Disposition Approval Resolution of 2014, effective December 2,
31	2014 (Res. 20-0705; 62 DCR 1091) ("Residential Townhomes Disposition Approval
32	Resolution"); McMillan Commercial Parcel Disposition Approval Resolution of 2014,

1	effective December 2, 2014 (Res. 20-0707; 62 DCR 1097) ("Commercial Disposition
2	Approval Resolution"); and McMillan Residential Multifamily Parcels Disposition
3	Approval Resolution of 2014, effective Fourth/Sixth and E Streets, S.W., Property
