This letter is submitted on behalf of TBSC Owner I, LLC (the "Applicant") as an amendment to the above-referenced application which seeks a modification of ZC Order No.15-20 (the Order") (the "Application"). The Zoning Commission is scheduled to consider the Application at its public meeting scheduled for July 30, 2018.

The Applicant seeks to amend the Application to include the following additional modification to the Order:

As noted in previous filings, the raze permit applications for the subject property were filed on April 11, 2018, but the updated contact information for the Sursum Corda Households was not

available until May 24th. Since that date, the Applicant has continued to work with Lonnie Duren, the president of the Sursum Corda Cooperative to further update the contact information for the Households. The most current contact information is attached. As with the original modification request, the modification proposed herein will not unreasonably delay relevant information to the Sursum Corda Households or the Department of Consumer and Regulatory Affairs related to the issuance of the raze permit. As such, we submit that the proposed modification is consistent with the intent of the original proffer. Also, based on their unanimous support of the original modification request, we assume Advisory Neighborhood Commission ("ANC") 6E would be supportive of this additional modification request.

In light of the foregoing, we respectfully request that the Zoning Commission approve the proposed modifications to Condition No. B.2.a. and B.2.e.i. at its public meeting scheduled for July 30th:
