Work to be performed for this project:

- 1. Inspect install. of 4 new fire hydrants connected to new 8" water main (8"x6" tee, 6" gate valve in casing): (i) 1 FH on private Neal PI NE; (ii) 2 FHs on private 3rd St NE; and (iii) 1 FH on private Morse St NE (include swivel tee).
- 2. Inspect install, of 1490LF of new 8" DIP CL56 water main loop on private alley, Morse St, 3rd St & Neal Pl NE. Include 13 gate valves, 1 blow off valve, 6-8" fire servs, 4-6", 8" & 4" dom servs, 4 Fire hydrant conns, & clay check dams on permeable alley.
- 3. Inspect installation of 705 LF of new RCPR combined sewer along private Morse St & 3rd St NE. Pipe sizes: 184 LF of 42", 67 LF of 36" & 454 LF of 30". Include a 6" straight thimble conns on Morse St NE and six-8" thimble conns on 3rd St NE.
- 4. Inspect installation of 14 new manholes (MH) over new CS on private 3rd St & Morse St NE. Include: a 6" SAN, a 24" & 2-8" STM laterals on Morse ST NE; and 2-8" & 4-12" SAN, 4-8" & 4-15" STM and a 30" CS laterals on 3rd St NE.
