Dear Troy:

An affiliate of Forest City Washington., Inc. ("FCW") is the master lessee of commercially operated parking lots containing approximately 600 spaces at The Yards in Southeast Washington, located at the corner of 1st Street SE and Tingey Place, SE (the "Lots"). FCW supports the development of the DC United Stadium and is willing to enter into a non-binding agreement to negotiate a contract with DC United (the "Team") for game-day event parking under the following terms:

- 1. FCW will make available up to 500 parking spaces (the "Parking Spaces") available for game day parking, excluding weekday day games, at the Lots for the Team's customers, visitors and invitees, on terms acceptable to both FCW and the Team.
- 2. There is an understanding that DC United games will not conflict with games and events at National's Park. The Parking Spaces will be unavailable when events are taking place at Nationals Park.
- 3. The Parking Spaces will be staffed and available 2 hours prior to the start of a game, and up to 2 hours after the game.
- 4. That the commencement of any agreement would be conditioned upon the development of the stadium.
- 5. This agreement will be subject to a mutual 90 day written termination notice by either party.
- 6. All visitors, guests and invitees will be subject to all rules and regulations of The Yards and will have rights to use all driveways, sidewalks, spaces and amenities at the Yards parking facilities.

Nothing contained herein shall be deemed to create any obligation or liability of either party to the other, and neither party shall have any obligation or liability to the other party unless and until a mutually-acceptable parking agreement is executed and delivered. I hope this is helpful and I look forward to working with DC United on this exciting project.
