The Office of the Zoning Commission has referred a text amendment proposed by the Office of Planning that would:

- Change how the height of basements and cellars are measured: instead of measuring to the
 ceiling of the basement/cellar, the new regulations propose measuring the height to the top
 of the finished floor of the "ground floor" (a defined term). The revisions also adjust the
 height above/below grade to five feet instead of four feet; and
- Establish the measuring point as the lower of either adjacent natural or finished grade.

To codify the new measurement guidelines for basements/cellars, the proposed text amendment revises the following definitions in Subtitle B, Chapter 1 of the Zoning Regulations:

- Areaway
- Basement
- Building area
- Building, Height of
- Building Height Measuring Point (BHMP)
- Cellar
- Floor Area Ratio (FAR)
- Grade, Finished
- Grade, Natural
- Gross Floor Area
- Habitable Room
- Story
- · Window well

Similar revisions for the proposed basement/cellar measurement are proposed for the Rules of Measurement regulations (Subtitle B, Chapter 3) and related rules of Subtitles D, E, F, J, and K.

Staff is supportive of these changes to Subtitles B, D, E, F, J and K of the zoning regulations that clarifies language adopted in 2016 regarding how the measuring point affects what is considered a basement or cellar as they are not inconsistent with the Urban Design Element of the Comprehensive Plan. These changes are not major ones, but rather minor amendments to the regulations and do not affect how a building's overall height will be measured, which is still governed by the Height of Buildings Act of 1910, as amended.
