**THE YARDS PARCEL G DESIGN REVIEW APPLICATION**

**MOTION TO MODIFY APPLICATION FEWER THAN 20 DAYS BEFORE THE PUBLIC HEARING**

Forest City SEFC, LLC (the “**Applicant**”) hereby requests leave from the Zoning Commission to modify the above-referenced application fewer than twenty (20) days before the public hearing to file updated plans and drawings reflecting refinements to the design of the application made in response to comments from GSA and other federal agencies.

Under Subtitle Z, Section 401.5, an application may not be modified fewer than twenty (20) days prior to a public hearing. The Applicant requests the Commission grant this motion to update an application seven (7) days before the public hearing. The Applicant seeks leave to file updates to its design in the afternoon of May 16, 2019. The updated designs will call out those areas of the design that have changed relative to the previous filing.

Granting the motion is in the public interest. The updates to the application reflect design refinements that improve upon the design of the application in response to comments from important federal agency stakeholders. The refinements to the design can be accomplished ahead of the noticed and scheduled public hearing, and it is in the best interests of the District, the federal agencies, and the Applicant to conduct the hearing as currently scheduled. In addition, the Applicant intends to include a list of proposed conditions.

The revisions to the proffer are the result the type of collaborative public process encouraged by the Commission and the Zoning Regulations. No party is prejudiced by this motion, which is not otherwise contrary to any law or regulation. The only party to this proceeding, other than the Applicant, is ANC 6D. The Applicant apprised the ANC of this motion and the proposed additional filing.

For the reasons stated herein, the Applicant requests the Commission grant this motion.
