ANC 6D is requesting a postponement on a final decision in ZC Case No. 19-23, Wells REIT II 80 M Street LLC, in order to more fully review and discuss with residents the light study submitted by the applicant four days ago.

The light study, which showed the effects of light on the Velocity condominium, during daylight hours requires further clarification by the applicant with respect to its impact at night. It is important for ANC 6D and the affected residents to understand the differences the light study will have on their homes when it is dark. While a few residents have been in contact with the applicant, neither ANC 6D or the condominium Board of Directors have had the same opportunity.

Since ANC 6D received the applicant's submission to the Zoning Commission four days ago, and have not met with the applicant prior to our February 10, 2020 business meeting, we are requesting a postponement so we can vote to support (or oppose) Case No. 19-23. Discussions with the applicant include installing sensors and shades in the building in order to mitigate the light impact however this has still not been approved by the Velocity Board of Directors.

ANC 6D's next scheduled business meeting is March 9, 2020 and we feel we can have resolution by then.
