RE: Zoning Commission Case 19-30

Dear Zoning Commission Members:

I respectfully request that you vote no on this controversial matter, which appears to be a scheme to raise building heights along Benning Rd, under the ruse of protecting the Advisory Neighborhood Commission (ANC) 5D05 community from pop-ups. Case 19-30 was brought by the Carver Langston Civic Association, which has no legal standing in any matter within ANC 5D05 or other affected community within the ANC 5D community. The Advisory Neighborhood Commission 5D (ANC) has not properly notified the community regarding the monthly community meetings; any vote to move this request forward was not done in accordance with the law. The ANC is required by law to notify the community in at least two ways to satisfy meeting notice requirements. The ANC 5D simply posts an occasional notice on their designated website, which the community does not have uniform access to. Most of the residents in ANC 5D05, 5D04 and 5D03 have no idea about this clandestine process. No notices regarding this case have been uniformly posted throughout the affected community, including Benning Rd. The Office of Planning should not have conducted the initial meeting to change the zoning within the proposed area, through the Langston Civic Association, which does not have legal standing akin to the ANC's to represent the community.

Commissioner Sydelle Moore is unknown to the community and consistently seeks to avoid and misinform residents when she is taken to task regarding 5D05 concerns. Ms. Moore is working surreptitiously with a handful of supporters that do little more than distort, mislead and lie about matters in the 5D05 community. Ms. Moore lied to residents regarding the benefits of being included in the Kingman Park Historic District and attempted to disrupt a well-attended meeting on 8-15, 2017, attended by State Historic Preservation Officer David Maloney and members of Office of Planning staff. Ms. Moore's residence is an Air B&B establishment and she regularly uses her visitors to pose as residents; none of these persons are registered voters or otherwise have any legal standing in the community. Juanita Diggs, who resides within ANC 5D04 is a part of the scheme to push case 19-30.

Finally, the properties 1835 H Street NE, 826 20th Street and others are being developed without proper permits and have received stop work orders and substantial fines for proceeding without proper permits. Residents also complained about 800 21st Street NE and another property in the 800 block of 18th Street and two properties in the 1800 block of I Street NE. There is D.C. Council hearing testimony regarding the illegal construction overlooked by then DCRA Director Melinda Bolling, despite multiple documented complaints from me in my capacity as the elected representative for ANC 5D05 and ongoing complaints documented in a petition signed by residents. I am the immediate past representative for 5D05. Case 19-30 is little more than a scheme to surreptitiously raise building heights, with the pretense of protecting the 5D05 community from further pop-ups. It is clear that DCRA did little to nothing then and continues to allow rogue developers to build without proper permits and to damage neighboring properties with seeming impunity. This is not justification for Case 19-30 and this case was not properly voted on and otherwise properly executed by ANC 5D. Ms. Moore is not credible and has knowingly filed multiple false complaints which are being investigated. Elected representatives are required to follow the law; Ms. Moore has not done so.

Alternatively, the Zoning Commission may table this matter until such time as ANC 5D follows the law in requesting a zoning change for ANC 5D communities and Benning Road. If approved, Case 19-30 will benefit Darcy Scott who is a developer and a member of Ms. Moore's small group of interlopers with a development scheme. Raising building heights has not resulted in the creation of affordable housing and using that argument in this instance is not supported by facts.

Thank you for your dismissal and or delay of this scheme (Case 19-30) that is offered without benefit of full public disclosure, notification and participation.

I am a fifteen-year resident of the Carver Terrace community, a devoted husband, father, and school principal and veteran of the U.S. Marine Corps. I attended a block party on September 22, 2018, in the 800 block of 21st Street, NE, which is around the corner from where I reside in the 800 block of 21st Street, NE. At the time, I was a candidate for the Advisory Neighborhood Commission (ANC), Single Member District 5D05. The block party was enjoyable, uneventful and I was glad to meet and chat with the neighbors in attendance. I am aware that Ashley Sydelle Moore filed a claim of stalking against Kathy Henderson, who was the elected representative for ANC 5D05 at the time. Ms. Moore alleges that Ms. Henderson caused a disturbance, requiring police intervention and was asked to leave the event. The allegation is completely false. Commissioner Henderson was well-received and everyone appeared to have a very enjoyable time.
