Dear Chairman Hood,

Per your instructions, I had an intelligent and respectful conversation with Mr. Robert Miller, Applicant/Owner of 2419 25th Street, SE, Washington, DC (proposed development project site/vacant lot). Nevertheless, I am continuing my opposition in this case based on my thorough research presented below:

- (1) The Advisory Neighborhood Commission 8B (ANC 8B) failed to provide the impacted community with adequate and proper public notice pertaining to the proposed development project, failed to take minute(s) setting forth the named presenter on the agenda for the proposed development project, voting and approval, with signatures, of all the ANC 8B commissioners who were present and participating in this action, as is required by the District of Columbia ANC's rules and procedures manual.
- (2) The boilerplate, July 23, 2020, ANC 8B Resolution, that was signed only by the Chairperson, Keeon Johnson, is unsupported by any documentation or ANC 8B signatures of participating commissioners, was contrary to actual ANC's protocols, rules and procedures, and thus shall not be given "great weight" by the zoning commission in this very important case.
- (3) The Community Benefits Agreement between ANC 8B and Wagner, LLC, is flawed with misrepresentations on multiple fronts, to wit: failed to provide the voting and approval of ANC 8B participating commissioners signatures in support of the Community Benefits Agreement terms, etc.
- (4) I suggest and suspect that the funding requested for the two organizations were not named because Chairperson Keeon Johnson and Commissioner Darrell Gaston, both have interests in the said two organizations. As a consequence, their actions clearly demonstrates serious conflict-of-interest concerns at best, and quid-pro-quo at worst. (Emphasis Added).

- (5) Families on the Rise, Incorporated, was lawfully registered in the District of Columbia Department of Consumer and Regulatory Affairs (DCRA) on February 27, 2015 (L00005110761). The address listed for this particular business is located at 1924 Trenton Place, SE, Washington, DC 20020. The Governor of the said business is Louise Thorne. Louise Thorne is the mother of Keeon Johnson, Chairperson, ANC 8B!
- (6) The Gerald Project, Darrell Gaston, is the Executive Director. Nevertheless, the Gerald Project is not lawfully registered on file at DCRA to conduct business in the District of Columbia (e.g., registered incorporation or basic business license).
- (7) Chairman Hood, if you consult the OP Hearing Report, page 10, dated September 10, 2020, the Zoning Commissioners will learn from the table under Uses of Special Value to the Neighborhood X Subsection 305.5(q), under the notes category: \$20,000-laptops, \$7,000-Families Rise, and \$5,000-Gerald Report, that the Chairperson, ANC 8B, withheld pertinent information from the Zoning Commission by omitting it in the ANC 8B Resolution and the Community Benefits Agreement documents that she and Commissioner Gaston had interests in the unnamed two organizations.
- (8) Mr. Robert Miller, Applicant/Owner, stated to me, via telephone conversation, that he delivered 55 laptop computers to ANC 8B Chairperson, Keeon Johnson, for distribution throughout 8B Commission. I am perplexed as to why the 55 laptop computers are not being delivered solely in single member districts (8B01, 8B02, and 8B03), proposed development site area where three elementary schools are currently located.
- (9) In any event, what will happen to the remaining \$14,500 if 55 laptop computers are valued at an estimated \$5,500? Additionally, Mr. Robert Miller, Applicant/Owner, stated to me, via telephone conversation, that he "had not" written checks to Families Rise and Gerald Project obligated in the Community Benefits Agreement document. Thank goodness for not writing those two checks!
- (10) The July 21, 2020, Community Benefits Agreement was only signed by the ANC 8B Chairperson and Wagner, LLC, without any supporting documentation or signatures of participating ANC 8B commissioners, in clear violation of well-established ANC Rules and Procedures. Additionally, ANC 8B "did not" participate in the Zoning Commission Hearing on September 24, 2020. Hence, cross-examination could not occur from the opposing party.
- (11) The remarks by you, Chairman Hood, that the proposed development project has strong community support is somewhat misplaced when the Zoning Commissioners review the attached Community Opposition Petition. (Emphasis Added).

In conclusion, Chairman Hood, I am respectfully requesting that the Zoning Commission delay its final vote in this case, refer this case to Simon Gottlieb, Director, Office of Advisory Neighborhood Commission, Kathy Patterson, District of Columbia Auditor, and the Board of Ethics and Government Accountability (BEGA), for their collective review, findings, and recommendations to be submitted to the Zoning Commission in case number 20-09 (Inspector General's Office, if necessary) based on my many serious concerns regarding conflict-of-interest

violations, ethical violations, ANC Rules and Procedures violations and for any other reasons these agencies shall find just and proper in the interest of substantial justice and fair play.
