Dear Chair Hood and Commissioners:

This is response to Chair Hood's request at the January 5, 2023 hearing on ZC Case 21-27, 1301 South Capitol Street, SW, that ANC 6D attempt to reopen the issue of the curb cut on N St. SW before the Public Space Committee, which ANC 6D has viewed as critical to traffic management in conjunction with the redevelopment project at 1301 So. Capitol St.

ANC 6D opposed this project, ZC 21-27 at 1301 So. Capitol St., in its testimony before the Zoning Commission principally because it continues to risk major traffic problems on N St.SW, which will endure and likely worsen as redevelopment in the area continues.

At the Chair's request, Commissioner Hamilton, in whose SMD the project lies, and I for ANC 6D, made multiple attempts, through email, voicemail and letters, to contact the Public Space Committee, explaining our inability to testify because of the rescheduling of the hearing on this case, and asking for permission to present ANC 6D's position at its next meeting, which would have been today, January 26, 2023.

Commissioner Hamilton and I finally received an email response from Courtney Williams, Executive Secretary of the PSC, yesterday, January 25, that decisions made by the Committee are final and therefore we were not permitted to testify on PSC Case #400985.
