Re: Petition for a Text Amendment to Subtitle K, Section 238.3 of the Zoning <u>Regulations</u>

Dear Chairman Hood and Commissioners:

We hereby submit this petition (the "**Petition**") for a text amendment to Subtitle K, Section 238.3 pursuant to Subtitle X, Section 1300, and Subtitle Z, Section 305.

The proposed amendment would allow office uses, including chanceries, in the SEFC-3 zone, where such uses are not currently permitted. This amendment proposes only to expand upon the uses allowed in the SEFC-3 zone and does not propose any changes to the development standards such as height or density. Moreover, any new office uses constructed under this proposed amendment would be subject to Zoning Commission design review pursuant to Sections 241 and 242 of Subtitle K.
