The current BZA 13902 created in 1983 requires the tenant of this location to provide 3 parking spaces for employees off site of the restaurant. The previous owner of the business provided parking for his employees over the years.

We purchased this business in 2018 and were made aware of the zoning requirement from 1983. I have come to understand that this BZA would no longer be applicable today under new zoning laws.
