LLC pursuant to 11 DCMR 3104.1 for a special 3 exception to allow additions to an existing hotel under Section 512 and a special 4 exception from the roof structure setback and 5 uniform height requirements under Subsection 6 7 411.11 in the SP-2 District at premises 1200 16th Street, N.W. which is in Square 182, Lot 8 9 826. The Board will recall also that 10 11 the hearing date of the original application 12 was January 29th, 2008. The Board decided this application on February 5th, 2008 and the 13 summary order was issued February the 7th, 14 15 2008. On March 21st, 2008, the Board 16 received this request for modification from 17 the Applicant. This is identified in your 18 19 case folders. Identified as Exhibit 38. 20 To date, no other parties have 21 filed written comments to this request for

modification.

Essentially, Madam Chair, the Applicant is requesting two things. One is to approve revised sheets 2.04R and 3.01R in this exhibit in order to increase the height of the screen wall as shown on these sheets as I've just pointed out and that's your exhibit. Which is contained in your Exhibit 38.

The second request the Applicant is requesting of the Board is that on the summary order that was issued there's a reference made to approved plans to Exhibit Number 26 and so, the Applicant's asking that Exhibit Number 34 which is in the record also be added to that summary order because Exhibit 34 contains sheet number 0, not 0, 0.03A, A as in alpha, which was the revised sheet to 0.03 submitted at the time of the hearing on January 28th and that completes the Staff's briefing, Madam Chair.

So, the only real issue I think is the change which is the raising of the screen as I understand it and our standard for a minor modification is that it doesn't change the material facts that the Board relied on in approving application and I'd like to take, you know, some comments on that.

So, in my view, it doesn't change the facts that we relied on. We were looking at bulk and height which were not affected by the original changes.
