1 things. One, it is up to the board's  
2 discretion whether or not we allow any of you  
3 or to individually or to collectively a party  
4 status. I believe based upon my quick  
5 observation and well not quick, well read all  
6 the stuff, is that you all probably qualify  
7 but prior to making a determination there's  
8 two things I'm going to ask you to do. Have  
9 any of you have followed the practices of the  
10 board, we ask that those who seek party  
11 status as well as the applicant meet and  
12 confer, to have dialogue before we call your  
13 case for a hearing to see if there are some  
14 differences that can be worked out prior to  
15 us calling your case. As you sit here you  
16 may not believe that can happen. But I've  
17 seen it happen in some very strenuous  
18 situations where you wouldn't think that ten  
19 different party status requests end up

1 practice to meet and have, attempt to resolve  
2 any issues that you may have. Additionally  
3 if you cannot work those things out, I'm  
4 going to ask those with party status to,  
5 because you all have similar issues, to meet  
6 and decide whose going to be the  
7 representative of the party status and the  
8 others can then also provide their statement,  
9 but a three minute statement, not actually  
10 serve in the capacity of party status. Your  
11 issues are all similar in regards to your  
12 party status request. If we put them in the  
13 requirements in the regulations that the  
14 board can consolidate party status or deny  
15 them completely. So, I'm going to ask you to  
16 do those two things. One, have conversation  
17 with the applicant to see if we can resolve  
18 on matters. And the applicant knows that its  
19 always better to try to work things out than  
20 for us to work it out for you. And the  
21 second thing for party status to have

9       I would suggest we set it for hearing for  
10      several reasons. One I'm not real clear, I  
11      think there's some questions regarding the  
12      relief that is being requested and to my  
13      understanding what is being called minor.  
14      But my initial review of it is that its  
15      actually adding another building to the plans  
16      and that's to me, on the face, is not minor  
17      because it materially changes the plans. So  
18      I believe we need to set it down, plus I  
19      think we don't have any input from the ANC.  
20      I would suggest that we get input from the
