3 If you're unfamiliar with how this
4 Board operates, there is a document to my left
5 by the back door, to my left which explains how
6 we handle meetings and hearings. So feel free
7 to get those documents.

8 If you're here to provide testimony
9 to the Board, by testimony I mean if you're
10 going to read a statement, if you're going to
11 be a witness, if you're going to say anything
12 to the Board, then I'm going to need you to do
